Supply of Supplies and/or Services</p> <p>2.1 The Provider shall provide the Supplies and/or Services on the terms and conditions set out in the Contract. Subject to the Provider fulfilling its obligations under the Contract SFRS shall pay the Provider in accordance with the terms of the Contract.</p> <p>2.2 In providing the Supplies and/or Services, the Provider shall comply with and take into account all applicable laws, enactments, orders, regulations and other similar instruments, the requirements of any court with relevant jurisdiction and any local, national or supranational agency, inspectorate, minister, ministry, official or public or statutory person of the government of the United Kingdom or of the European Union.</p> <p>3. Contracts for Supplies</p> <p>3.1 The Supplies shall be to the reasonable satisfaction of SFRS, shall conform to any particulars specified in the Specification, Purchase Order and/or the Contract Particulars, shall be free from defects and be fit and sufficient for all the purposes for which such Supplies are ordinarily used and for any particular purpose made known to the Provider by SFRS.</p> <p>3.2 The Supplies shall be delivered to the location(s), and at the times and dates specified in the Specification, Purchase Order and/or Contract Particulars or any other written instruction provided by SFRS, and time of delivery shall be of the essence. If no times and dates are specified, the Supplies shall be delivered promptly following the date of this Contract. Except where otherwise provided in the Specification, Purchase Order</p>

<p>3.4 SFRS may by reasonable written notice to the Provider reject any of the Supplies which fail to meet the requirements specified herein, and shall be entitled (without prejudice to other rights and remedies) either to have the Supplies repaired or replaced (at the option of SFRS) or to treat the Contract as discharged and seek damages from the Provider. The issue by SFRS of a receipt note for the Supplies shall not constitute any acknowledgement of the condition or nature of those Supplies.</p> <p>4. Contracts for Services</p> <p>4.1 The Provider shall provide the Services in accordance with SFRS's requirements which are set out in the Contract Particulars,</p>	<p>5. Charges</p> <p>5.1 In consideration of the satisfactory performance of the Provider's obligations under the Contract by the Provider, SFRS shall pay the Charges.</p> <p>5.2 SFRS shall pay the Provider, in addition to the Charges, a sum equal to the Tax chargeable on the value of the Supplies and/or Services provided in accordance with the Contract.</p> <p>5.3 Subject to 5.4, payment of invoices accepted by SFRS will be made within 30 days of receipt and agreement of invoices for work completed to the satisfaction of SFRS to a bank account of which details shall be provided by</p>

Timely provision of the Services shall be of the essence of the Contract, including in relation to commencing the provision of the Services.</p> <p>4.2 The Provider shall perform the Services with all reasonable care, skill and diligence, and in accordance with good industry practice. The Provider warrants and represents that all persons engaged by the Provider for performance of the Services have the qualifications, skill and experience necessary for the proper performance of the Services.</p> <p>4.3 If SFRS informs the Provider that SFRS considers any part of the Services to be inadequate, without prejudice to clause 4.5 below, the Provider shall at its own expense re-schedule and perform the work correctly within such reasonable time as may be specified by SFRS.</p> <p>4.4 Without prejudice to SFRS 's other rights and remedies, the Provider shall reimburse SFRS for all reasonable costs incurred by SFRS which have arisen as a direct consequence of the Provider's delay in the performance of the Contract.</p> <p>4.5 In the event that SFRS is of the opinion that there has been a Default by the Provider in respect to the Services, then SFRS may, without prejudice to its other rights herein: make such deduction from the Charges as SFRS shall reasonably determine in respect of such of the Services as the Provider has failed to provide and/or terminate the Contract in whole or in part in accordance with clause 18.</p> <p>shall be confirmed by the sending party.</p> <p>8. Interest</p> <p>Interest shall be payable on the late payment of any undisputed Charges properly invoiced under this Contract at a rate per annum equivalent to 2% above the Bank of England's base rate current on the date upon which such Charges first become overdue. No person who is not a party to the Contract shall have any right to enforce any term of the Contract, which expressly or by implication, confers a benefit on him without the prior agreement in writing of both parties.

9. Security

The Provider shall comply with all reasonable security requirements of SFRS while on SFRS's premises, and shall procure that all of its employees, agents, servants and sub-contractors shall likewise comply with such requirements. SFRS shall provide the Provider upon request copies of its written security procedures. SFRS reserves the right to refuse to admit to, or to withdraw permission to remain on, any of its premises, the Provider or any sub-contractor, agent or servant of the Provider.

10. Intellectual Property Rights

10.1 It shall be a condition of the Contract that the Supplies and/or Services will not infringe any Intellectual Property Rights of any third party and the Provider shall fully indemnify and keep indemnified SFRS against all actions, suits, claims, demands, losses, charges, costs and expenses which SFRS may suffer or incur as a result of or in connection with any breach of this clause.

10.2 All Intellectual Property Rights in any specifications, instructions, plans, drawings, patents, patterns, models, designs or other material prepared by or for the Provider for use, or intended use, in relation to the performance of the Contract shall belong to SFRS .

11. Assignment and Sub-Contracting

The Provider shall not assign, sub-contract or in any other way dispose of the Contract or any part of it without prior written consent of SFRS.

The Contract shall not be varied or amended unless such variation or amendment is agreed in writing by SFRS and the Provider

14. Remedies Cumulative

Except as otherwise expressly provided by the Contract, all remedies available to either party for breach of the Contract are cumulative and may be exercised concurrently or separately, and the exercise of any one remedy shall not be deemed an election of such remedy to the exclusion of other remedies.

15. Indemnity and Insurance

15.1 Neither party excludes or limits liability to the other party for death or personal injury caused by its negligence or for any breach of any obligations implied by Section 12 of the Sale of Supplies Act 1979 or Section 2 of the Supply of Supplies and Services Act 1982.

15.2 The Provider shall indemnify and keep indemnified SFRS against injury (including death) to any persons or loss of or damage to any property which may arise out of the act default or negligence of the Provider, any sub-contractor or their respective employees or agents, and against all claims, demands, proceedings, damages, costs, charges and

15.3 The Provider shall procure and maintain the following minimum levels of insurance during the Contract period;

15.3.1 £5,000,000 for public liability and where appropriate and relevant product liability insurance in respect of any one act or default. The insurance policy or policies shall be extended for the purpose of the Contract by

Waiver</p> <p>The failure to insist upon strict performance of any provision of the Contract or to exercise any right or remedy shall not constitute a waiver of that right or remedy, no waiver shall be effective unless it is expressly stated to be a waiver and communicated to the other party in writing, and a waiver of any right or remedy shall not constitute a waiver of any right or remedy arising from any other or subsequent breach of the Contract.</p> <p>15.4 The Provider shall maintain professional indemnity and product liability insurance and any other appropriate and relevant insurance at the above levels for a period of ten years after the end of this Contract and shall notify SFRS in writing immediately should such insurance cover cease.</p> <p>15.5 If so required the Provider shall furnish SFRS with certificates of insurance together with the receipt or receipts for premiums evidencing that the relevant insurances are in force.</p> <p>15.6 In no event shall either party be liable to the other for:</p> <p>15.6.1 indirect or consequential loss or damage; and/or</p> <p>15.6.2 Loss of profits, business, revenue, goodwill or anticipated savings.</p> <p>16.
